




1. ALL WORK SHALL BE DONE IN A NEAT AND WORKMANLIKE MANNER AND IN ACCORDANCE

2. CONTRACTOR'S SUBMITTAL OF A BID REPRESENTS THAT HE HAS VISITED THE SITE AND IS FAMILIAR WITH EXISTING CONDITIONS THAT MAY AFFECT ANY PORTION OF THE WORK.

3. THE PLANS AND SPECIFICATIONS CONTAINED HEREIN REPRESENT THE SCOPE OF WORK TO BE PROVIDED. CONTRACTOR SHALL PROVIDE ALL WORK SHOWN ON THESE DOCUMENTS AND ALL WORK THAT CAN BE REASONABLY INFERRED TO BE INCLUDED. CONTRACT OFFICER SHALL BE THE SOLE INTERPRETER OF THE INTENT OF THE PLANS AND SPECIFICATIONS. CONTRACTOR SHALL VERIFY ALL DIMENSIONS AND CONDITIONS AND SHALL NOTIFY THE CONTRACT OFFICER OF ANY DISCREPANCIES BEFORE PROCEEDING WITH THAT PORTION OF

4. IN ALL CASES, CARE SHALL BE TAKEN TO CREATE AS LITTLE NUISANCE AS POSSIBLE. CORRIDORS SHALL BE KEPT FREE OF HAZARDOUS EXTENSION CORDS, EQUIPMENT, TRASH, AND OTHER SITUATIONS THAT COULD RESULT IN INJURY TO VISITORS OR EMPLOYEES OF THE

CONTRACTOR SHALL ACQUIRE AND PAY FOR ANY AND ALL PERMITS OR FEES THAT MAY BE




